Tuition includes athletics, student passes to all home athletic events, fine arts, laptops (8th-12th grade), curriculum, field studies, middle and high school retreats, and individualized academic, college, and scholarship advising.

APPLICATION FEE

A non-refundable Application Fee is due upon applying.

- Early Decision Applications: October 1-January 31 | \$125 Application Fee
- Open Applications: February 1-April 30 | \$175 Application Fee
- Special Consideration and Mid-Year Transfers: May 1 and Later | \$225 Application Fee

NEW STUDENT FEE

A non-refundable New Student Fee of \$1,200 is due per new kindergarten through 12th grade student at the time of enrollment.

MULTI-STUDENT DISCOUNT

A kindergarten through 12th grade multi-student discount is available and will automatically be applied with the following provisions:

- The discount rates are 5% for the second student, 10% for the third student, 15% for the fourth student, and 20% for the fifth student. The 5% discount applies to the student in the second highest grade, the 10% discount applies to the student in the third highest grade, etc.
- The multi-student discount does not apply to families who receive need-based tuition assistance. If the multistudent discount is greater than the tuition assistance award, a family may opt to receive the discount in lieu of tuition assistance.
- · To be eligible for the discount, the students must be in the same family tuition billing account.

TUITION PAYMENTS

Tuition payments may be made annually, semi-annually, or monthly through FACTS. Families may choose the 5th, 10th, 15th, 20th, or 25th of each month as their payment date. Automatic payments may be made from a checking or savings account or a variety of credit cards, if applicable. FACTS charges an annual fee of \$55 per family for monthly payments, \$25 for semi-annual and annual payments.

- Monthly payments: 12 equal installments from May 2024 to April 2025
- · Semi-annual payments: due by May 25, 2024, and November 25, 2024
- · Annual payments: due by May 25, 2024

ENROLLMENT COMMITMENT

Students who withdraw from February 23, 2024, to December 15, 2024, will be charged half of the annual tuition. Students who withdraw on or after December 16, 2024, will be charged the full annual tuition.

ADDITIONAL PROGRAM: KNIGHTS AFTER SCHOOL CARE | PRESCHOOL-5TH GRADE, 3:00-6:00 P.M.

A \$25.00 registration fee is required for every family. The annual plan is payable three ways: \$333.33 per month, September through May, two payments of \$1,500 each in September and January, or one payment of \$3,000 in September. The scheduled use plan is payable monthly at \$17 per day of use; days must be selected at the time of enrollment.
